You qualify for this service if:

- Family income is less than \$65,000.
- All income is documented.
- You have no rental income or other similar "out-of-scope" tax issues.

Be sure to bring:

Picture IDs for Taxpayer & Spouse—**REQUIRED!**

Social Security Cards or Individual Taxpayer Identification Number (ITIN) letters for taxpayers and any person to be claimed as a dependent on the return, including children-**REQUIRED!**

AFFORDABLE CARE

- *IRS Form 1095-A if health insurance was purchased through the ACA Marketplace.
- *Forms 1095-B and/or 1095-C, if received.

Income information, including all W-2s and 1099s for wages, pensions, self-employment records, interest, dividends, & other capital transactions.

Last year's tax return (if available).

For the Childcare tax credit, bring employer Identification Number (EIN or SSN) of all providers.

Tuition expenses paid for college (Form 1098-T), plus expense records for books, equipment, & supplies.

Checking or savings account information for direct deposit of refunds.

If you want to itemize, bring information on medical and dental expenses, mortgage interest, charitable contribution records, and other taxes.

**Refunds direct deposited
between 8 & 15 days
or mailed within 22 days.**
